• Proposal: New Business Proposals must be submitted to the chair at least 1 week prior to the monthly business meeting.

If an alcoholic suggests a proposal at the meeting, they will be asked to prepare a brief summary and submit it to the chair as explained above, for consideration at the next meeting.
